Dear friends and colleagues,

I'm writing to let you know that the Government Law Center will hold two roundtable discussions on police reform under Governor Cuomo's [Executive Order 203](#). These discussions will be an opportunity for anyone involved in the process, including local officials and community members, to hear about how other jurisdictions are responding to the order: what's being included in reform plans, as well as what procedures are being followed. The Government Law Center has spoken with numerous municipalities about their response to the Executive Order, and the single thing we've heard the most often is a desire to compare notes with other municipalities. We hope these forums will be a useful opportunity to do that.

Each roundtable will begin with a brief summary of what's happening in various localities; we'll provide examples of plans that have been issued by various jurisdictions for you to consider. (The Government Law Center has compiled some examples of the draft plans that have been circulated so far; you can find links in this [spreadsheet](#).) We'll also have a discussion of some key issues that many municipalities are considering. We'll invite folks from the municipalities to speak to each other in an open discussion, moderated over Zoom, so that folks can learn from each other's experience to the greatest extent possible.

The first roundtable, on February 9, is open to anyone with an interest in the police-reform processes that are going forward under the Executive Order. The second roundtable, on February 18th, will focus specifically on rural communities, whose challenges are in many ways unique.
