I just had electricity restored on my road after a lengthy outage, so I can put away the parchment and pigeons. I'm backed up with emails, so I will attempt to address several ongoing threads here--

The new fiber optic digital phone service (which runs off point-of-use AC transformed to DC, not DC through the phone line like regular copper) is vulnerable to failure during power outages. The power failed here at about 4:00PM, the battery backup (a little battery box next to the digital interface box) kicked on, and failed overnight (about 12 hours later) with only 5 minutes of total phone usage and 1 of 2 landlines unplugged for local DC conservation at the jacks. The power

remained out about another 31 hours past phone failure. "All of that" for a non-catastrophic outage--a pole with a transformer snapped when a wire was pushed down by a tree branch down the road--about a six-hour fix, but the supervisor (or more than one watching it on shifts) apparently couldn't get a work crew to respond for 2 days.

This is the moment in most of my hypothetical conversations when someone quips (in Jim Varney voice)-iguessitsabouttimetogetyourselfagenerator, vern (with a bit of Schoharie chortle), except here everyone calls one another "bud," and this conversation circle is already far too dignified for common admonitions and any talk from me of socialized public utilities, so I can close my circular logic circuit at this dot.

I would likewise question the wisdom of local municipalities paying Lexipol or any other similar outfit a nickel. They're not just a consultant, as apparently these firms retain material copyright but assume no content liability. The village of Cobleskill was convening a special board meeting for entry into executive session a couple of weeks ago, and I assume it revolved around the potential retaining of Lexipol, which appears to be something of a wonder-boy in these matters right now. I assume local municipalities are taking a line of thought that, once the lawsuits pile up on police officers, the municipalities will more likely be able to motion for separation of the municipality, as a named respondent, from primary responsibility in liability. At that point, even if a federal civil jury finds for the plaintiff (police victim), and the municipality defended the cop(s) (named co-respondent in official capacity) with its own lawyers, and the municipality pays the judgment against the individual cop(s) in official capacity, the ultimate judgment will be much lower than for a finding of primary responsibility against the named municipality (say, for inadequate training, supervision, or policy as employer). Municipalities can now argue that they had a "best practices" specialized contractor write their policies for them, and their training, supervision, and policy is perfect.

Meanwhile, police agencies continue to take up inordinate municipal budgetary resources and payroll power (you ought to check out the Cobleskill village budget one of these days or examine payrolls on seethroughNY). In Cobleskill, the village can't even have meetings in its own municipal building, it has to use the volunteer firehouse because the police department takes up most of the municipal building behind locked doors.

To put it in plain-old simple terms--the police are king of the hill right now, and the People are too anxiety-ridden to legislatively abolish or restructure police agencies. The society runs like a dysfunctional family right now--the police (in general) stand at the top of a power hierarchy at the local level, and nobody, neither public interest group nor government nor citizenry, feels confident or mature enough to rise to maturity and handle their own affairs as mature adults without a big brother present. We are unable to handle our own affairs as a civil society and craft democratic intent for our own government, because we're too busy competing with one another as pawns in a game of neoclassical-economic capitalism (the big picture beyond the myopia; the true chessboard).

Sooner than me sit in that snow job of a committee process at the County Building, or beg for the attention of hard-up pawns (fellow citizens), I might as well just lay out my deepest wisdom here. The police get paid a handsome wage to sit in these committee meetings, as does the district attorney (paid nearly two hundred thousand dollars a year), the public defense coordinator, and the county administrator. Other officials get paid less. The public gets paid nothing to sit there and get depreciated by sophistry (I honestly cannot think of any more dignified term for it in the English language) for hours at a time.

I feel it necessary to describe my own self-standard and character that I hold as my truth. To quote the civil rights movement: "I am A Man." I seek the truth, not politics. If anyone wishes to approach me and speak with me, I welcome you. If you phone me, I will phone you back (so long as the phones are working). If you email me, I will respond. If you call to me in my car from the corner, I'll park it somewhere safe and get out and speak. You can drive down my driveway, and I'll offer you hospitality and we can speak as long as you desire (so long as I am here, but don't come down the driveway in the winter if it hasn't been plowed and salted yet, it's easy to get stuck). I have all the time in the world, or at least as much as anyone who claims he doesn't.

I've been invited to meet up with a citizens' assembly in Cobleskill, which unfortunately had to be postponed. I believe several of you on this combined thread were planning to meet up. I prefer to meet up in the evening, but can do any time with enough pre-scheduling. I would also prefer to meet up with Rural Awakening principal leadership at some point, as they seem to have a hand in this citizens' assembly. However, that is my personal preference in the matter, and I am more than happy with this citizens' assembly going forward without Rural Awakening if they lack the maturity to collaborate.

So, there it is--came out about as long and varied as a Christmas card letter. Hope it touches all bases with my friends from during this phenomenal power outage-
