Good afternoon Mayor Stanton-Terk,

Thank you for reaching out. I am currently considering my own thoughts on Andrew Cuomo's listed policy points, and will let you know when I formulate them. Please read ahead if you have the time.

What I am more concerned about right now are the mathematical power plays at work in our society and involving the police in general (not just local agencies and agencies inside NYS). The police occupy the (computational-mathematical) social and guild station they are in because of a larger primitive hierarchy of the society. The greater society remains dysfunctional and unable to maturely manage their own affairs as an economically advanced, first world democratic society. They turn to the police, who play a role of "ground managers" inside the dysfunctional system, like an overseeing responsible sibling in a family role system. The police get nearly free rein of the allegorical house, but like the rest of the family, they don't ever rise to mature self-actualization as full members of the advanced society they live in (although many are recognizing this and trying).

My own role in social action is dysfunctional and primitive, because I play something like an archaic "neighborhood steward" or street captain who champions the voiceless masses as they toil in the coal mines. Except, there's no mines, and our communities are largely middle class and educated and fully capable of speaking for themselves. We live in the most powerful and wealthy (and ultimately democratic) society on earth, and its social regressions are just that--psychological withdrawals from mature and civilized functioning.

I hypothesize that a passive and unintended "payroll cabal" exists locally in the Capital District. The metropolitan regional economy is so dependent on government sectoral work that it fosters a "silent monolith" among the middle class. The dysfunctional social system is passively accepted, because it is misinterpreted as keeping the public sector flush with (misperceived) scarce work, and the region lacks the confidence to envision its own future and recover itself through development of a healthy, balanced economy and metropolitan society.

A fully mature stance for the greater American society would be to maintain healthy, robust, and supportive bureaucracies that seek developmental best practices for the society, but also develop fully encompassing, supportive and equitable social economies, as nearly all of the rest of the first world has done since about 1965. It's the U.S. that is practicing primitive hierarchy and hegemony, not the other way around as is falsely parroted within the nation's internal rhetoric. Cobleskill could be a verdant and form-perfect community and life center, same for every single other community in this country.
