WHEREAS, as a result of Executive Order 203 signed by Governor Cuomo, the Schoharie County Law Enforcement Review Committee was established, and
WHEREAS, the Committee consisting of the members of the Schoharie County Board of Supervisors Law and Judicial Committee, the Schoharie County Sheriff and members of his Department and community representatives were given the mission to study Schoharie County Sheriff's Department policies, practices, procedures and racial equity, and
WHEREAS, a significant number of interested Schoharie County citizens also participated in the study and provided significant input and recommendations to the Schoharie County Law Enforcement Committee, and
WHEREAS, based on five months of meetings and reviews, the Schoharie County Law Enforcement Committee produced a detailed report including topics discussed and correspondence between members of the committee and correspondence from interested members of the public with specific recommendations for the Schoharie County Board of Supervisors for adoption, rejection or amendment, now, therefore, be it hereby
RESOLVED, the Schoharie County Board of Supervisors accepts the following consensus actionable recommendations of the Schoharie County Law Enforcement Review Committee:
 Citizens Collaborative Committee [or name TBD]-As discussed and agreed by the Sheriff's Office at the February 9, 2021 Law Enforcement Review Meeting and further discussed at the February 16, 2021 meeting, a Citizens Collaborative Committee [CCC] will be established for the purpose to meet quarterly to discuss law enforcement issues as it relates to the Schoharie County Sheriff's Office. As appropriate, the CCC will report to the Schoharie County Board of Supervisors Law Enforcement and Judicial Committee any findings or recommendations. If accepted by the Law Enforcement and Judicial Committee, the recommendations will be forwarded to the full Board of Supervisors for comments and/or adoption. The CCC will consist of five Schoharie County citizen members appointed by the Board of Supervisors to two-year terms, the Sheriff or his/her designee, and one member of the Board of Supervisors outside of the Law Enforcement Judicial Committee.
Law Enforcement Data Information- Once available the Schoharie County Sheriff's Department and Citizens Collaborative Committee will review arrest data collected by the Court systems. The data will be accessed on the public websites of the Division of Criminal Justice Services and the Office of Court Administration mandated by the State under the New York State Police Statistics and Transparency Act enacted June 2020.
