MINUTES

1820-30-Book B- Town Record- Lists for every year: Supervisor, Town Clerk, Assessors (spelled asfesfors), Poor Master, Commissioner of Highways, Commissioner of Common Schools, Inspector of Common Schools, Collector, Constables, Fence Viewer and Pound Master, Path Meister (Master I believe), Election Certificates, Overseers of Highways

1831-1901- School Statistics-bits and pieces through these years (there is not entries for every year) Lay out of the school districts and additions, alterations and deletions of districts .

1830-1874-Book C- Town Record- Index: Town officers, By Laws, School Report (but there is nothing listed), Election Certificates, Record of Strays, School Districts, Road Surveys.

1874-1922- Minutes- Index: Town Officers, Overseers of the Road Districts, By Laws, Road Boundaries, Alterations of Road Districts, Road Districts, School Districts, Board of Health Resolutions, and Canvas the votes.

Minutes-1951-63, 1964-74, 1974-82, 1983-96, 1996-2003 and to present

OTHER RECORDS

1869-1929- Town Accounts, Summit NY is settlements of Town officers.

1893-1906- Account Book, (I believe, cover is missing) - Headings: Poor Fund, Dog Fund, School Fund, Excise Fund, Highway Fund, Bridge Fund, Road Machine Tax, receipts.

1863-1872 & 1873-89 & 1890-1901- Assessment Role, lists names of taxable inhabitants and dog tax for 1866.

1935-60- Record of Contracts of Conditional Sale - Headings: Buyer, Seller, Description of Goods, Price, Date of Contract, Time of Filing, Cancellation, Renewed. (mostly sale of cows, horses, cars)

1943-47 & 1948-51 & 1951-56- Record of Fees Received-Headings: Resident, non-Resident, Citizens Licenses, Alien, Deer and Dog Licenses, Contracts.

1953-61- Cash Book Receipts- Headings General Fund, Highway Fund, Special District.

"Summit 1920"- Real Property-Headings: Name of Owner, Last Known or Reputed Owner, Location of Property (Name of Village and Name of Number of School Districts and Special Districts Where property is Located), Location Street or Road, Side of Street of Road (East, West etc), Lot or Street Number, Names of the Abutting Property.

1952-88- Town Ordinance Book.

1849-1907 & 1908-34 & 1934-61- Chattel Mortgages, in alphabetical order. Headings: Name of Party Giving Mortgage, Name of Person to whom Mortgage is given, Date of Mortgage, Time of Filing, Date Due, Cancelled, Renewed.

1953-78- Register of Bonds, only 17 pages are used

1943-53- Record of Claims Received, only 16 pages are used. Headings: Name of Claimant, Character of Claim, Fund to Which Charged, Amount of Claim, Amount at Which Audited, Date Audited, Date Audited, and Date Paid.

1900-17, 1907, 1938- Justice's Civil Docket, there's a bunch more to list.

1895-1910, 1937-41 -Criminal Docket

1967-Summit Grange #1536 Calendar listing Birthdays and Anniversaries.

1891-92- David N. Brown Blacksmith Shop Book (ledger).

1934,36, 38, 53- Summit Jurors List.

1914-15- Summit #2 (Village School) Register of Attendance.

1946 & 62- Summit #3 (Oliver School) Tax Rolls.

1925-33- Summit ME Church ledger.
