<b>Residential Construction</b>	
<b><u>Project Cost</u></b>	<b><u>Application Fee</u></b>
Up to \$5,000	\$50.00
\$5,001 and above	\$50.00 for the 1st \$5000 and remainder multiplied by .005
*Building Permits are based on total applicant cost of project.	
*Building Permits valued under \$500,000 shall expire if the work authorized has not begun within 90 days after the date of issuance or has not been completed 12 months from the date of issue.	
*Building Permits valued over \$500,000 shall expire if the work authorized has not begun within 90 days after the date of issuance or has not been completed 18 months from the date of issue.	
*One six-month extension of a building permit may be applied for at half the original permit fee cost.

Construction started without a valid building permit fees will be doubled.	
After hour and weekend inspections will be billed at the rate of \$30/hr. (min. fee \$30).
